



# Bowen Island Moorings – Boat Registration

Each JBDC member is entitled to nominate one boat as their primary dive platform. The nominated vessel will be registered with Booderee Park Authority. This vessel will be permitted to use the moorings located adjacent to Bowen Island, whilst that member is on board. The JBDC Mooring Code of Practice and the Booderee Parks Authority mooring policies must be strictly adhered to. The JBDC committee may, at its' own discretion, revoke the boat's and / or the member's privilege to use the moorings, where the member is found to have breached the rules, or conducted themselves in an inappropriate manner. The JBDC registration of nominated vessels will be updated with Booderee Park Authority quarterly, or as required. Your registration will only be valid for one calendar year. You will be issued with a pennant to designate privilege of mooring use at a cost of \$15. Pennant is required to be handed back if membership ceases [\$15 is non- refundable] or if vessel is no longer a nominated vessel. You will be given a copy of the JBDC Mooring Code of Practice and the Booderee Mooring Policy with the issue of your pennant

## Code of Practice

- A member may nominate 1 boat to be registered with Booderee Park Authority for use of the moorings.
- The member registered for use of the flag must be on board or diving from the vessel when it is in use. It is up to the member to ensure that the flag remains in their possession and not left on the boat when not in use. .
- Members are required to register annually on the date of their membership renewal. Boats that are not nominated for registration at the time of membership renewal, will be removed from the registration list with Booderee.
- Members are required to pay a one-off usage fee of \$15, upon receipt of which, a pennant indicating legitimate privilege to use the moorings will be issued to the member.
- Members are required to submit, with their application, a recent photograph of the boat being registered. The photo may be submitted digitally in JPEG format at 640x480 resolution.
- In the event that the 'Registration for Mooring Use' expires or is no longer required, the member will surrender the pennant to the committee. No refund will be given for the pennant.
- Members are required to fly the pennant whilst on the mooring to indicate JBDC membership and privilege of use.
- The member must be present and in control of the pennant when using the moorings ie: the pennant cannot be lent to other boats or persons.
- Members are encouraged to apply common sense and courtesy to other JBDC members and Commercial operators.
- The pennant is to be flown on the nominated vessel only. The pennant is not transferable.
- Members may not conduct any activity for profit whilst displaying the Mooring pennant
- Members will be issued the Booderee Mooring Use Policy with their pennant, and are required to use the moorings in accordance with those guidelines and the JBDC Code of Practice.
- Any breach of the Policy or Code of Practice may result in the forfeit of the privilege of use, as deemed appropriate by the committee.
